On February 27, the 2023 Shanghai Commerce Situation Briefing was held in the form of "main site + sub-sites" and "online + offline". The briefing was hosted by Gu Honghui, Deputy Secretary-General of the Shanghai Municipal People's Government, where Hua Yuan, Shanghai Vice Mayor, delivered a keynote speech. Shen Weihua, Deputy Director of the Shanghai Municipal Commission of Commerce, presented a report on the key tasks of the city's commercial sector in 2023. SHFIA organized 46 member enterprises including Sanofi, Michelin, Shanghai Disney Resort, L'Oréal, 3M, and BASF to participate in event at the main site. Empowering SMEs Seminar Series: IKEA's Approach to Purchasing and Supply Chain Management

On February 10, SHFIA held the first session of its "Empowering SMEs" seminar series in 2023, themed "IKEA's Approach to Purchasing and Supply Chain Management". The seminar invited Song Yan, Strategic Purchasing Manager of IKEA Purchasing and Logistics Area East Asia, to introduce IKEA's purchasing model and supplier management, and share IKEA's best practices in supply chain management. Attracting 107 representatives from SHFIA member enterprises, it helped SMEs optimize their supply chain management and enhance supply chain efficiency and resilience.

Seminar on "Escaping the Second Recession-2023 Global Macro Outlook" by FIEs Community@Hongqiao

On February 14, the Hongqiao International Central Business District's FIEs Community@ Hongqiao held its first event of the year themed "Escaping the Second Recession-2023 Global Macro Outlook". The seminar invited Chen Dafei, a senior macroeconomic analyst from Sinolink Securities, to introduce the global economic cycle, compared global economic recessions since the 1960s, and analyzed the economic trends of the US, the EU and emerging markets in 2023, and proposed the outlook of China's development strategies such as the "Dual Circulation" growth pattern, expansion of domestic demand, and industrial upgrading. Nearly 60 representatives of enterprises and government agencies from Shanghai and the Yangtze River Delta region attended the seminar. Also at the event, Zhu Yinghua, Deputy Director of the Investment Promotion Division at the Administration Committee of the Shanghai Hongqiao International Central Business District, presented the district's four key functions, namely "transportation, commerce, exhibition, and innovation", as well as its key advantages and industrial layout. On February 21, SHFIA's Japanese Enterprises Branch held the Seminar on Sino-Japanese Economic Trends and New Year Symposium for Japanese Enterprises at the city's Garden Hotel. As the branch's first event of the year, it attracted representatives of more than 70

- 1. Professor Li Xiaogang, Director of the Foreign Investment Research Center at the Shanghai Academy of Social Sciences, shared the current status of Sino-Japanese relations and the prospect of future trends;
- 2. Zhang Wule, a police officer from the Shanghai Public Security Bureau Huangpu Branch, presented China's latest immigration policies; and
- 3. Member enterprises engaged in free interaction and exchange.

At the seminar, officials from the People's Bank of China Shanghai Head Office and the State Administration of Foreign Exchange Shanghai Branch presented relevant policies such as cross-border RMB settlement and foreign trade payment facilitation, while the CCB Shanghai Branch shared related products and services, and invited business representatives to share and exchange views on experiences of settlement facilitation. The seminar attracted a total of more than 150 enterprises to participate, either online or offline.
