Huang Feng, Chairman of SHFIA and Cheng Yi and Wang Wei, Deputy Directors of the Foreign Document Management Division of the Exit-Entry Administration Bureau of Shanghai Municipal Public Security Bureau attended the meeting. Representatives from Yum, Bayer, DSM, Fermax, Ford Motor, Jaguar Land Rover, Herbalife, Corning, and Mizuho Bank attended the meeting. Deputy Director Cheng Yi introduced relevant policies on foreigner's visa, residence permit and permanent residence ID card. July 21

The 2021 liaison meeting of the Auto Branch of SHFIA was held at the SAIC Volkswagen MEB Factory in Jiading. Nearly 40 representatives from member companies, leaders and staff of the Auto Branch Secretariat attended the meeting. Liu Sheng, Vice Chairman of SHFIA, attended the meeting. Zhou Chengchao, Secretary-General of the Auto Branch, reported the work of the branch in 2020 and the work plan for 2021.

Representatives from SAIC Volkswagen, SAIC General Motors, Aptiv, Porsche, Ford, Volvo and Huayue gave speeches at the meeting. They focused on the challenges posed by new energy vehicles companies on the traditional automobile companies as well as the future development of new energy vehicles. Participants also raised suggestions on how to improve the work of the Auto Branch. After the meeting, they visited the SAIC Volkswagen MEB Factory.
