威能(中国)供热制冷环境技术有限公司

Vaillant, 德国威能,总部位于德国北莱茵·威斯特法伦州雷姆沙伊德市,拥有 140 多年的发展历史,是欧洲供热/生活热水/通风及空调设备制造商。威能非常注重采暖技术的人性化设计,相继推出了闭合系统的热水器、壁挂式燃气热水器等。威能集团专注于为家居生活的舒适性提供智能化解决方案。140 多年来,威能集团是供热、生活热水领域的市场先行者,全球 60 多个国家拥有超过 3 千万顾客。截至 2021 年 11 月,威能集团旗下共计拥有八大国际品牌,在欧洲 6 个国家及中国无锡共设有 10 家工厂及产品研发中心,并拥有欧洲的产品检测实验室,全球员工超过 15000 人。

丹佛斯 (上海) 投资有限公司

丹佛斯是电气化、数字化和智能制造领域的全球领导企业。公司下设气候方案、传动和动力系统三个事业部,产品和服务覆盖冷链、空调、商业楼宇及住宅供暖、城市区域能源、电机控制系统、电源模块、污水处理、移动和工业液压、电气化等应用领域。丹佛斯还活跃于太阳能、风力发电、储能、新能源电动汽车等行业,为新能源等新兴产业提供核心半导体技术及器件。

丹佛斯 1933 年成立于丹麦诺德堡,现有员工 40,043 名,产品行销 100 多个国家,全球布局 95 家工厂。2022 年 3 月,丹佛斯硅动力事业部与塞米控公司宣布将在全球范围内展开合作,将大幅提升丹佛斯在电气化领域核心技术能力。2021 年 8 月,丹佛斯集团以 33 亿美元完成对伊顿液压业务的收购,进一步巩固了丹佛斯在移动和工业液压领域的全球领导地位。近年来,丹佛斯在中国进行了一系列重大投资,持续提升"第二家乡市场"的战略地位。另外,从疫情开始至今,集团在积极转移产线的同时,完成了

天津武清、浙江海盐、江苏镇江等基地研发能力的全面升级,积极推动从"中国制造"向"中国创造"转变。

北京世辉(上海)律师事务所

世辉律师事务所是一家以服务高科技公司为特色的综合性律所,总部位于北京,在上海、深圳设有分支机构。世辉的客户均为行业领军公司和著名投资机构。目前世辉有 30 余位合伙人,近 200 名法律专业人员。世辉在兼并收购、证券与资本市场、私募股权、投资基金、外商直接投资、境外投资、财富管理、资产证券化、争议解决、合规、反垄断/竞争法、数据保护、劳动用工、知识产权等业务领域均有杰出表现。

上海富士工器有限公司

上海富士工器有限公司是由上海燃气集团有限公司与日本富士工器株式会社,日本株式会社琦酸、日本株式会社东海公司等四家中日企业共同出资建立的合资企业,于 1997年 11 月建成投产。技资总额达到四亿一千万日元, 占地面积 7500 平方米。公司经营范围是生产一吨以下液化气压力容器, 液化气小区供气配套设施及液化气驱动汽车的容器, 销售自产产品。 目前主要生产 150kg、 300kg、500kg 的立式横式等各类新型液化气贮槽以及与日本液化气行业配套的各类金属部件, 并且全部出口到日本, 目前在日本液化气贮槽市场占有量接近 50%,系目前我国压力容器出口数量最多的厂商。2021年因经营需要,整体搬迁至奉贤区青港工业园区,新厂占地面积 12000 平方米,贮槽年产量可以达到 9000 台左右。

上海长喜置业有限公司

上海长喜置业有限公司成立于 2006 年 9 月 18 日,是一家中日合资企业。由日本长喜开发株式会社和上海长喜商务咨询有限公司共同出资组建。上海长喜置业有限公司所属的上海长喜集团旗下拥有长喜咨询、长喜房地产、长喜建筑、武好体育等多家公司,分属于不同行业领域。并且在江苏、浙江、北京、广州以及美国和韩国都有分公司或事务所。目前,上海长喜置业有限公司嘉定园区内有数十家企业,分别来自美国、法国、日本、意大利等多国,分布在汽车、食品、新材料等各个领域。

Shanghai Commerce Commission leadership visited SHFIA for field survey

On January 30, Gu Jun, Party Secretary and Director of the Shanghai Municipal Commission of Commerce (SMCC), and Zhu Yi, Deputy Director of SMCC, visited SHFIA for field survey. They were received by SHFIA Chairman Huang Feng, and Vice Chairman and Secretary-General Liu Sheng.

Chairman Huang Feng presented the work summary of SHFIA's 8th Board of Directors over the past four years and the work plan for 2023. SMCC Director Gu Jun fully affirmed SHFIA's work since its reelection in 2019, saying that SHFIA's work has been tightly connected to the themes of the times such as the 100th Anniversary of the Founding of the Communist Party of China and green, low-carbon development, and the establishment of SHFIA's member liaison system has enhanced the relationship between the association and enterprises and closely followed their actual situation. Under the leadership of Chairman Huang Feng, SHFIA has inherited its legacy to continue building a home community for foreign enterprises, and has echoed the characteristics of the new era to innovate its way of working.

Gu also put forward requirements for SHFIA's work in the next stage. In 2023, the focus of Shanghai's foreign investment work is to expand new investment, stabilize existing investment, and improve investment quality, so SHFIA's work should fully support the focus – on top of well serving foreign enterprises in Shanghai, the association should foster a better business environment and let enterprises feel that "they've made the right decision to invest in Shanghai". Since 2023 will be a year when opportunities outweigh challenges, SHFIA should seize opportunities, overcome challenges, and seek synergies, so as to build Shanghai into a promising land for foreign enterprises. Vaillant Group (China) Heating, Cooling and Environmental Technology Co., Ltd.

Founded in Remscheid in 1874, the Vaillant Group today supplies innovative hot water, room heating and cooling solutions to countries all over the world. As a global market and technology leader in the fields of heating, ventilation and air-conditioning technology. Vaillant develops high-efficiency products that save energy, conserve resources and enhance people's quality of living.

In 1995, Vaillant officially entered the Chinese market. In 2015, Vaillant moved its functional headquarters and core business units in China to Shanghai as regional headquarters. In 2021, Vaillant has sold more than 2,000,000 wall-hung boilers in China.

From a geographical perspective, Vaillant's commercial activities focus on the whole of Europe, Turkey, Russia and China and has around 30 million customers. Our three Segments - Climate Solutions, Drives and Power Solutions - provide a wide range of products and services being used in areas such as cold chains, air conditioning systems, heating systems for both commercial and residential buildings, city district energy infrastructures, electric motor control systems, customized power modules, water and wastewater treatment, mobile and industry hydraulics and electrification. We are also a global player in renewable energy industries ranging from solar energy and wind power to energy storage and e-vehicles, offering key semi-conductor technology and components to emerging new energy industries.

Danfoss was founded in 1933 in Nordborg, Denmark. Today, the Group employs 40,043 talents, selling products in more than 100 countries, operating 95 factories worldwide. In March 2021, Danfoss and SEMIKRON announced a merger to create a joint business focusing on power semiconductor modules to build a leading partner in Power Electronics. In August 2021, Danfoss finalized its USD 3.3 billion acquisition of Eaton's hydraulics business, establishing itself as a global leader in mobile and industrial hydraulics. In recent years, Danfoss has been investing heavily in China to further enhance China's strategic importance as the company's "Second-Home Market". Since the outbreak of the pandemic, Danfoss has been proactively optimizing global production line layout, while successfully upgrading its innovation capacities in its campuses in Wuqing, Haiyang, and Zhenjiang, in an effort to transition from "Made in China" to "Created in China".

Beijing Shihui (Shanghai) Law Firm

Shanghai Fuji Koki Co., Ltd. is a joint venture co-established by four Chinese and Japanese companies including Shanghai Gas Group Co., Ltd. and Japan Fuji Koki Co.,

Ltd. It was put into production in November 1997. With a total investment of over JPY 400 million, the company covers an area of 7,500 square meters, and its business scope is to produce liquefied gas pressure vessels below one ton, gas supply facilities for liquefied gas communities, and containers for liquefied gas-powered vehicles, and market such self-produced products. At present, the company mainly produces 150kg, 300kg, 500kg vertical/horizontal-type and other types of liquefied gas storage tanks and various metal parts that match the Japanese liquefied gas industry – all products are now exported to Japan, accounting for nearly 50% of Japan's liquefied gas storage tank market, making the company China's largest exporter of pressure vessels. In 2021, due to business needs, the company was wholly relocated to the Qinggang Industrial Park in Fengxian District, with the new factory covering an area of 12,000 square meters, and the annual output of storage tanks reaching about 9,000 units.

Shanghai Choki Properties Develop Co., Ltd.

Established on September 18, 2006, Shanghai Choki Properties Develop Co., Ltd. is a Sino-Japanese joint venture jointly funded and established by Japan Choki Development Co., Ltd. and Shanghai Choki Business Consulting Co., Ltd. Shanghai Choki Properties Develop Co., Ltd. is a subsidiary of Shanghai Choki Group, which owns a number of subsidiaries in different industries, such as Choki Consulting, Choki Real Estate, and Choki Construction. The group also has branches or offices in Jiangsu, Zhejiang, Beijing, Guangzhou, the US, and South Korea. At present, the Jiading campus of Shanghai Choki Properties Develop Co., Ltd. has drawn dozens of companies from countries including the US, France, Japan, and Italy, which operate in various sectors such as automobiles, food, and new materials.
