

"新专利法解读讲座"政策讲座

8月4日,协会举办"新专利法解读"政策讲座,邀请高级专利代理师围绕 新专利法的不丧失新颖性例外、专利保护期限补偿制度、药品专利链接制 度和纠纷早期解决机制、专利开放许可和强制许可、诚实信用原则和非正 常申请、专利侵权赔偿金额和惩罚性赔偿、外观设计相关制度七个方面对 新专利法修改内容作全面解读。

"新修订的《上海市消费者权益保护条例》带来的变化、影响和机遇"政 策讲座

SHFIA held a symposium for foreign-invested enterprises

On August 8, SHFIA held a symposium for foreign enterprises, with Chen Deming, former president of the China Association of Enterprises with Foreign Investment (CAEFI), Cao Hongying, executive vice president of CAEFI, and Huang Feng, Chairman of SHFIA. Representatives from 10 of SHFIA's member enterprises talked about the impact of the COVID-19 pandemic on the business development and investment plan of foreign enterprises, as well as their opinions and suggestions on China's future economic policies.

Chairman Huang Feng attended foreign-invested enterprises symposium to mark the third anniversary of Lin-gang Special Area and delivered a speech

On August 22, a symposium of foreign-invested enterprises to mark the third founding anniversary of the China Shanghai Lin-gang Special Area Pilot Free Trade Zone was held. Officials including Chen Jinshan, member of the Standing Committee of the CPC Shanghai Committee, secretary of the Party Working Committee and director of the Administrative Committee of Lin-gang Special Area, Ren Ruanqing, Deputy Director of the Shanghai Municipal Development and Reform Commission, and Zhu Yi, Deputy Director of the Shanghai Municipal Commission of Commerce, attended the event. More than 20 representatives of foreign-invested enterprises, including member enterprises such as PwC, attended the forum.

In his speech, Huang Feng said since the establishment of Lingang New Area three years ago, SHFIA has been paying attention to and participating in the area's foreign investment work. In April 2021, SHFIA signed a memorandum of understanding with Lingang New Area. SHFIA's Healthcare Committee organized foreign pharmaceutical and healthcare enterprises to visit Lingang. And SHFIA actively participated in Lingang investment promotion, with a number of member enterprises settling in the area. In the future, SHFIA will continue to encourage more member enterprises to invest in Lingang and cooperate with the area's administrative committee to carry out investment promotion, rights protection and policy training.

2021 top-10 cases of "Collaborative Innovation" by foreign-invested enterprises were published

On August 29, the opening ceremony of the 2022 Global Tech-Matching Fair was held. Xu Feng, Party Secretary of the Shanghai Science and Technology Committee, Chen Dong, Deputy Director of the Shanghai Science and Technology Exchange Center, and Huang Feng, Chairman of SHFIA, jointly presented awards to foreign-invested enterprises that were named the 2021 top-10 cases of "Collaborative Innovation."





SHFIA EVENTS

SHFIA held 10 events in August and 82 events from January to August.

"Ten Years of Photography Journey in Tibet" Sharing Session by Shanghai Hong Kong Joint Publishing Co., Ltd.

On August 19, SHFIA and Shanghai Hong Kong Joint Publishing Co., Ltd. jointly held a sharing session of "Ten Years of Photography Journey in Tibet," which was attended by more than 50 employees from SHFIA's member enterprises. A senior Tibetan photographer shared Tibet travel tips, landscape and culture, taking participants to virtually tour the plateau region. During the event, more than 120 photos on Tibetan landscapes and the stories behind them were also shared, showcasing Tibet's beautiful scenery and unique culture.

Policy seminar on "Understanding New Patent Law"

On August 4, SHFIA held a policy seminar on "Understanding Chinas' New Patent Law," and invited a senior patent agent to comprehensively interpret the law's latest revisions, including exception to loss of novelty, patent protection term compensation system, drug patent linkage system and early dispute resolution mechanism, patent open licensing and compulsory licensing, good faith principle and abnormal application, patent infringement compensation amount and punitive damages, and design related system.

Policy seminar on "Changes, Impacts and Opportunities Brought About by the Newly Revised 'Regulations on the Protection of Consumer Rights and Interests in Shanghai'''

On August 10, SHFIA held a policy lecture on "Changes, Impacts and Opportunities Brought by Newly Revised 'Regulations of Shanghai Municipality on the Protection of Consumer Rights and Interests," and invited Tang Jiansheng, deputy secretary-general of the Shanghai Consumer Council, to explain highlights of the new regulation. Tang Jiansheg interpreted the key points of the regulation that relate to the New Consumption sector, including livestreaming e-commerce, big data-enabled price discrimination and cross-border e-commerce and shared case studies to explain the impact of the new regulation on enterprises' products, services and marketing activities. He also introduced the regulation's new mechanism to promote the positive interaction between consumers and business operators.

Skill training on "Customs AEO Advanced Certification Management and Internal Audit"

On August 9 and 18, SHFIA held two skills training sessions on "Customs AEO Advanced Certification Management and Internal Audit," which invited senior experts on enterprise customs affairs management and enterprise AEO certification to explain customs AEO advanced certification management and internal audit of import and export activities.

Policy lecture on "How Foreign-Invested Enterprises in China Can Handle Data Export with Ease"

On August 22, SHFIA invited Guo Yulan, partner of Beijing Dentons (Shanghai) Law Firm, to give a seminar on compliance issues of cross-border transfer of personal information that foreign-invested enterprises in China need to handle according to the "Guidelines for Network Security Standards — Security Specification for Certification of Cross-border Transfers of Personal Information," "Standard Contractual Provisions for Personal Information Export (Draft for Comments)" and "Measures for Security Assessment of Data Exports." By analyzing three approaches, namely assessment by network security authorities, certification of personal information protection by specialized organization, and signing of standard contracts, Guo offered reference for the data compliance management practices of foreign-invested enterprises in China.

Policy seminar on "Intellectual Property Operation and Patent Open Licensing"

On August 30, SHFIA held a policy seminar on "Intellectual Property Operation and Patent Open License Pilot," and invited relevant officials from the IPR Application & Promotion Department of the Shanghai Intellectual Property Administration to introduce the city's current work in intellectual property operation and the pilot program of patent open licensing. At the seminar, officials explained the basic concepts and main models of intellectual property operation and presented ongoing projects that foster high-value patents, special program of patent transformation to optimize Shanghai's intellectual property operation environment, and essential information related to patent open licensing.
