Fang Huiping, Director of the Municipal Consumer Protection Commission, attended the meeting, Hu Hao, First-level Inspector of Shanghai Municipal Market Supervision Bureau, Luo Zhisong, Chief Economist of Shanghai Municipal Commission of Commerce, Tao Ailian, Secretary General of Shanghai Municipal Consumer Protection Commission and Second-level Inspector of Shanghai Municipal Market Supervision Bureau, and Huang Feng, Chairman of SHIFA, attended the meeting. # The First "Member For Member" (MFM) event of the Association - Essilor Eve Care Salon was Held

The first "Member For Member" (MFM) event of the Association - Essilor Eye Care Salon was held at Kinetic Space of Jing'an Kerry Center. Lu Jianzhong, President of Public Affairs of Essilor Greater China and Chairman of the Supervisory Board of the Association, and Jessica Li, Executive Deputy Secretary General of the Association, attended the event and delivered speeches. Employees and family members from member companies such as ABB, Henkel, Ezaki Glico, Cook Medical, Brose, Faurecia, IKEA, Lianheng Isocyanate and CIG Shanghai attended the event.

Ophthalmologists from Essilor and partner LensCrafters introduced eye care knowledge on youth myopia prevention and control, adult visual fatigue relief, UV protection, as well as presbyopia prevention for middle-aged and elderly people and control and contact lens use, and answered questions about eye health and contact lens. Eye health screening was also conducted on site, with ophthalmology professionals checking eye pressure, refractive error and corneal health through professional eye screening equipment.
