2021年度外商投资协会联席会议举行

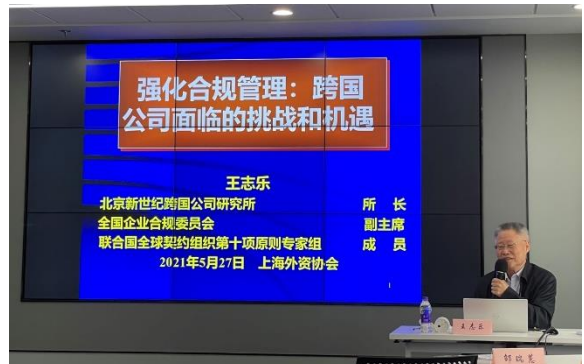

5月26日，百事公司举办植根中国40周年庆祝活动。协会会长黄峰应邀参加。

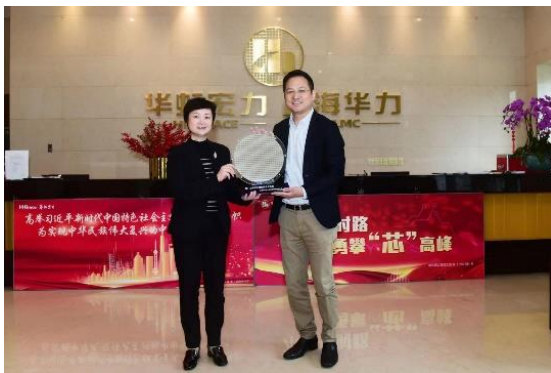

2021 Joint Conference of Shanghai Foreign Investment Association and District Foreign Investment Associations held in May

On May 11-12, the Joint Conference of Shanghai Foreign Investment Association and District Foreign Investment Associations was held in Chongming. A total of 25 representatives from the Shanghai Foreign Investment Association (SHFIA), Pudong, Huangpu, Jing'an, Changning, Putuo, Yangpu, Jiading, Jinshan, Qingpu, Fengxian, Chongming Foreign Investment Association and Minhang District Enterprise Federation participated in the Conference to discuss topics such as how to build highly effective operations to better serve foreign investment companies. At the meeting, the representatives reviewed their respective work in 2020 and share plans for 2021, as well as exchanged how to deepen collaboration between the associations. Through the joint conference, the ties between the associations have been strengthened.(Image 1)

SHFIA organized member companies to participate in the event "Entering Shanghai Municipal People's Congress"

On May 27, SHFIA organized 11 member companies to participate in the event "Entering Shanghai Municipal People's Congress, Special Court Session." Chen Jing, Deputy Director of the Standing Committee of the Shanghai Municipal People's Congress, Liu Xiaoyun, Secretary of Party Leadership Group and President of the Shanghai High People's Court attended the session. A total of 11 representatives from foreign-funded enterprises first observed a contract dispute case tried by the Commercial Tribunal of Xuhui District People's Court and then exchanged with representatives from Shanghai Municipal People's Congress and heads from Shanghai High People's Court Commercial Tribunal, Intellectual Property Tribunal, and Financial Tribunal on creating a world-class legal business environment and Commercial Tribunal work of Shanghai Court.

SHFIA organizes member companies to participate in the foreign-funded enterprises symposium held by the Development Research Center of the State Council

On May 28, SHFIA organized 12 member companies to participate in the symposium held by the Development Research Center of the State Council and exchanged views on topics including the impact of tax exemption policy discontinuation for foreigners and current problems encountered by multinational companies' regional headquarters and R&D centers. Heads of member companies such as Boehringer Ingelheim, Ford and Cabot attended the meeting. Long Guoqiang, Deputy Director of Development Research Center of the State Council and other leaders attended the symposium. Huang Feng, Chairman of SHFIA, attended the meeting.

The Third "Fuji Cup" FIE Photo Contest

SHFIA EVENTS

On May 11, The European Union Chamber of Commerce in China Shanghai Chapter held 2021 Europe Day event. Huang Feng, Chairman of SHFIA, attended.

On May 12, SHFIA and the Environmental Defense Fund jointly held a case sharing session on corporate carbon emission management. Hu Dongwen, a Senior Engineer from the Low Carbon Economy Research Center of Shanghai Environment Engineering Institute, introduced current situation of corporate carbon management in the context of carbon neutrality and peak carbon dioxide emissions. The sharing session invited four member companies, including Bosch, Kingfisher, Dow Chemical, and IKEA China, to share their corporate carbon emission management cases and experiences. More than 80 companies including DuPont, Philips, Starbucks and Pepsi participated in the sharing session.

On May 18, SHFIA held a lecture on Policy of Import and Export of Dangerous Chemicals and Packaging Inspection and Supervision, and invited Wang Shundong, Section Chief of Commodity Inspection Department of Shanghai Customs, to interpret the General Administration of Customs of 2020 (Announcement 129 on Issues Concerning Import and Export of Dangerous Chemicals and Packaging Inspection and Supervision) and related content. 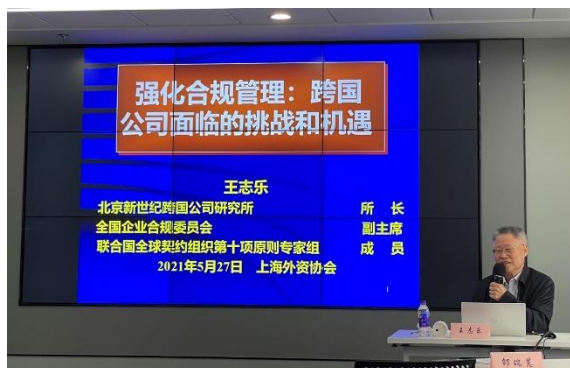

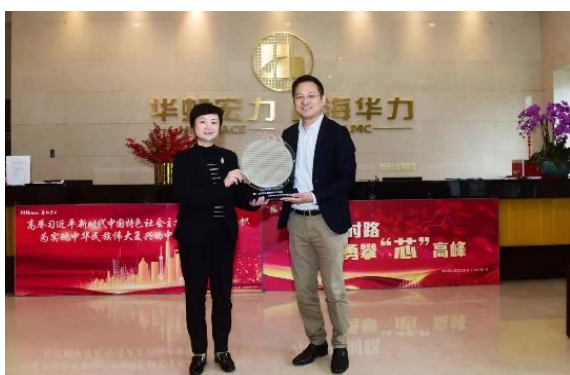

Our globally managed premium is over USD \$700 million annually. Pacific Prime China was set up in 2003 as one of the very few WOFE insurance intermediaries operating in China and serves as an especially important strategic location for our global platform.
