On December 3, the presentation ceremony for the 2023 Shanghai Magnolia Silver Award was held, where 50 outstanding foreign nationals from 15 countries including Armenia, Australia, Brazil, Canada, France, Germany, Italy, Japan, South Korea, Netherlands, Romania, Singapore, Sweden, the UK and the US received the much-coveted honor. Kong Fu'an, Director of the Shanghai Municipal People's Government Foreign Affairs Office, attended the ceremony and delivered a keynote speech, and Huang Feng, Chairman of SHFIA, was invited to present medals and certificates to award recipients.

SHFIA co-organized joint meeting for Shanghai's city- and district-level foreign investment associations

On December 15, the 2023 Shanghai Joint Meeting of Municipal- and District-Level Foreign Investment Associations was held in Hongkou District. The meeting was co-organized by SHFIA and the Hongkou District Foreign Investment Association (HDFIA), and attended by representatives from foreign investment associations of Pudong, Jing'an, Xuhui, Putuo, Yangpu, Minhang, Jiading, Jinshan, Songjiang, Qingpu, Fengxian, and Chongming. Hosted by Yao Jingli, Secretary-General of HDFIA, the meeting also saw the presence of officials including Zhu Xiaoyi, Deputy Director of the Hongkou District Commerce Commission, and Rao Yuxun, Deputy Director of the Baoshan District Commerce Commission.

Zhu Xiaoyi, Deputy Director of the Hongkou District Commerce Committee, first welcomed the representatives from various district commerce commissions and foreign investment associations, before Liang Meifen, Chairman of HDFIA and Senior Managing Director of Chongbang Group, thanked the municipal- and district-level government departments and foreign investment associations for their support to her association. And foreign investment associations of each district reviewed their respective work in 2023, and conducted in-depth discussions on topics such

Huang Feng, Chairman of SHFIA, listened to the speeches and sharings by the foreign investment associations of each district, reviewed the exchanges and collaborations among the associations, and called on them to strengthen exchanges, integrate resources, share development, seek pragmatic cooperation, and explore the establishment of a larger-scale, more comprehensive long-term cooperation mechanism in a wide range of areas. Policy Seminar on Data Resource Consolidation and Data Asset Valuation

On December 1, to help enterprises better understand data capitalization policies and perform related accounting treatments, SHFIA held a policy seminar on data resource consolidation and data asset valuation. It invited He Zheng and Ren Zheng, both partners from Deloitte China, to interpret relevant policies, and drew more than 30 finance professionals from foreign enterprises. Ren and He made detailed interpretations of the *Interim Provisions on Accounting Treatment Related to Enterprise Data Resources (Ministry of Finance 2023 No.11)* and the *Guiding Opinions on Data Asset Appraisal (China Appraisal Society 2023 No.17)*, and shared relevant financial practices and typical cases for enterprises.
