Shanghai Standardization Collaboration Platform for Foreign Enterprises: Symposium on the Guidelines for the Graphic Labeling of Nutritional Ingredients of Pre-packaged Foods (*Draft for Comments*)

To help foreign enterprises further understand the requirements for food nutrition labeling in the national standard *Guidelines for the Graphic Labeling of Nutritional Ingredients of Prepackaged Foods (Draft for Comments)* and guide enterprises to correctly label the nutritional ingredients of their food products, the Shanghai Standardization Collaboration Platform for Foreign Enterprises organized a symposium. It was attended by experts and officials from the Chinese Nutrition Society, the Shanghai Municipal Administration for Market Regulation, the Shanghai Municipal Health Commission, and the Shanghai Municipal Center for Disease Control and Prevention as well as representatives from 8 foreign enterprises.
