# 协会 28 家会员企业参加上海市 2025 年优化营商环境大会

2月5日,春节后首个工作日,上海市召开2025年全市优化营商环境大会。市委书记陈吉宁出席并讲话。市委副书记、市长龚正主持会议。市人大常委会主任黄莉新、市政协主席胡文容出席,市委常委、常务副市长吴伟部署2025年上海市优化营商环境工作。

28 SHFIA member enterprises attended 2025 Shanghai Conference on Optimizing the Business Environment

On February 5, the first working day after the Chinese New Year holiday, Shanghai held a conference on optimizing the business environment in 2025. Chen Jining, Secretary of the CPC Shanghai Municipal Committee delivered a speech at the conference, which was chaired by Shanghai Mayor Gong Zheng. Huang Lixin, Director of the Standing Committee of the Shanghai Municipal People's Congress, and Hu Wenrong, Chairman of the Shanghai Municipal People's Conference, were present at the conference, and Executive Vice Mayor Wu Wei made arrangements for the city's efforts to optimize the business environment in 2025.

SHFIA was entrusted to invite executives from 28 member enterprises including Johnson & Johnson Medtech, Hella, Lesaffre, INVISTA, Goodyear, Nippon Express, and Aptiv to attend the conference. Simon Yang, President of Aptiv Asia Pacific, took a media interview after the event.

2 月 19 日,由市商务委主办的"2025 年上海商务情况通报会"成功举办。市委常委、 副市长华源出席会议并讲话,市政府副秘书长刘平主持会议。市商务委主任朱民通 报了本市 2024 年商务运行情况和 2025 年商务领域重点工作安排。 协会组织了赢创、和记黄埔医药、金光外滩、欧莱雅、威立雅、威可楷等 238 家在 沪外资企业代表参会并参与现场问答互动。市商务委、市发改委、市规资局、市委 金融办、市外办、市经信委、进博局、浦东新区政府、虹桥国际中央商务区管委会 现场解答了大家关心的问题。

#### SHFIA organized representatives from 238 foreign enterprises to attend 2025 Briefing on Shanghai's Commerce and Development

On February 19, the "2025 Briefing on Shanghai's Commerce and Investment" hosted by the Shanghai Municipal Commerce Commission (SMCC) was successfully held. Shanghai Vice Mayor Hua Yuan delivered a speech at the briefing, which was chaired by Liu Ping, Deputy Secretary-General of the Shanghai Municipal People's Government. Zhu Min, Director of SMCC, reported on the city's commerce and investment landscape in 2024 and the key work arrangements in 2025.

SHFIA organized representatives from 238 foreign enterprises, including Evonik, Hutchison Whampoa Pharmaceutical, Golden Bund Real Estate, L'Oreal, Veolia, and YKK, to attend the briefing and participate in the on-site Q&A session. Officials from SMCC, the Shanghai Municipal Development and Reform Commission, the Shanghai Municipal Bureau of Planning and Resources, the CPC Shanghai Municipal Committee Financial Office, the Shanghai Municipal Foreign Affairs Office, the Shanghai Municipal Commission of Economy and Informatization, the China International Import Expo Bureau, the Pudong New Area Government, the Administration Committee of the Shanghai Hongqiao International Central Business District answered questions of concern on the spot.

#### 第一期知产沙龙

2月27日,上海市外商投资协会第一期"知产沙龙"活动在协会大会议室举办。黄峰 会长出席并致辞,来自协会会员企业的20多位企业代表、专家参与并作交流。 协会法务总监王烨君介绍了协会筹办知识产权专业委员会(筹)的计划和愿景。在 知识产权专业委员会的工作机制下,协会将进一步整合各方知识产权资源,搭建知 识产权学习交流的平台,共同促进知识产权保护、保护品牌价值、促进技术创新。 作为知识产权专业委员会交流学习平台中的板块之一,"知产沙龙"将以灵活多样的 形式不定期举办。此外,协会还将开展"知产大讲堂"、"法总朋友圈"等活动,发挥 各类政企对话渠道的优势,在推动知识产权法治方面发挥积极影响力。

与会企业代表、专家分别结合企业所在行业,探讨在知识产权保护领域所面临的挑战,并表达了见解和观点,为协会下一步的知识产权工作开拓了新思路。现场还通 过调查问卷的形式,征集了企业和专家对协会知识产权工作的建议和意见。

#### **First Session of SHFIA Intellectual Property Salon**

On February 27, the first session of the "SHFIA Intellectual Property Salon" was held at the association's grand conference room, where Chairman Huang Feng delivered a speech. More than 20 representatives from SHFIA member enterprises and experts attended the salon for exchange of views.

SHFIA Legal Director Wang Yejun introduced the association's plan and vision for organizing the Intellectual Property Committee (now in preparation). Under the working mechanism of the Intellectual Property Committee, SHFIA will further integrate the intellectual property resources of all parties, build a platform for learning and exchange, and co-promote intellectual property protection, brand value protection, and technological innovation. As part of the Intellectual Property Committee's exchange and learning platform, the "SHFIA Intellectual Property Salon" will be held in a flexible and diverse form with an unfixed schedule. In addition, SHFIA will also carry out activities such as "Intellectual Property Lecture Hall" and "Legal Director Club" to give full play to the advantages of various government-business dialogue channels and play a positive role in promoting the rule of law in intellectual property. The participating enterprise representatives and experts discussed the challenges faced in the field of intellectual property protection in combination with the industries they're in. They also shared insights and opinions, which inspired new ideas for SHFIA's follow-up work in intellectual property work. The salon also collected suggestions and opinions from enterprises and experts on SHFIA's intellectual property work through questionnaires.
