

On September 29, the 2025 Presentation Ceremony of the "Shanghai Honorary Citizenship" was held in Shanghai. Shanghai Mayor Gong Zheng met with honor recipient Simon Lichtenberg, Founder and CEO of Trayton Group, to present the medal and the certificate. Huang Feng, Chairman of SHFIA, was present at the ceremony as the representative of the Lichtenberg's nominating organization.



市对外友协会长陈靖率上海外资企业代表团赴新疆投资考察

9月9日至13日,上海市人民对外友好协会会长陈靖率上海外资企业代表团赴新疆投资考察。代表团成员来自丹麦、法国、意大利、日本、新西兰、新加坡、瑞典、瑞士、英国、美国等10个国家的26家在沪知名企业,涵盖金融投资、电气机械、医疗卫生、跨境电商、现代物流、农业食品、文化旅游等行业,其中11家为世界500强企业。

9 月 13 日,新疆自治区党委副书记、自治区主席艾尔肯·吐尼亚孜会见代表团。期间,自治区人大常委会副主任李宁平、王国和、买买提明·卡德、自治区副主席、喀什地委书记聂壮分别与代表团见面或参加相关活动,与企业家们热情交流,推介新疆的开放政策和投资环境,表示愿为各国企业来疆投资发展提供更加市场化、法治化、国际化营商环境。在自治区各有关单位和地、市的精心安排下,代表团一行先后赴霍尔果斯、喀什、乌鲁木齐跨境口岸、自贸区、高新园区、特色产业等参访交流,参加乌鲁木齐市招商推介座谈会,与新疆相关部门及企业家面对面交流对接。

9月12日,由外企代表团与市工商联组织的边疆行代表团、在沪企业商会联合会组织的走进新疆企业代表团、市青年企业家代表团、上海市光彩会组织的"为了花朵的微笑公益团"青年企业家等共计 200 余人汇聚喀什,举行了"2025 沪疆产业合作大会"。企业家们踊跃交流发言,分享了投资新疆、投资喀什的成果和意向,共话沪疆产业合作广袤前景。

上海市驻疆办主任、上海援疆工作前方总指挥孟庆源、市政府合作交流办副主任强 鹏程、市对外友协副会长宿琳、市外资协会秘书长范红等陪同参加相关活动。此次 投资考察活动由市对外友协和市外商投资协会联合主办。

Chen Jing, Chairman of SPAFCC, led delegation of Shanghai-based foreignenterprises on investment inspection tour to Xinjiang

From September 9 to 13, Chen Jing, Chairman of the Shanghai People's Association for Friendship with Foreign Countries (SPAFCC), led a delegation of Shanghai-based foreign enterprises on an investment inspection tour to Xinjiang. The delegation included 26 well-known Shanghai-based enterprises from 10 countries, including Denmark, France, Italy, Japan, New Zealand, Singapore, Sweden, Switzerland, the UK, and the US. They spanned sectors including finance and investment, electrical machinery, healthcare, cross-border e-commerce, modern logistics, agriculture and food, and cultural tourism, with 11 of them being Fortune 500 companies.

On September 13, Erkin Tuniyazi, Deputy Secretary of the CPC Xinjiang Autonomous Region Party Committee and Chairman of the Xinjiang Autonomous Region Government, met with the delegation. During the visit, Li Ningping, Vice Chairmen of the Standing Committee of the Xinjiang Autonomous Region People's Congress, Wang Guohe, Mamatimin Kader, and Nie Zhuang, Vice Chairmen of the Xinjiang Autonomous Region Government and Secretary of the CPC Kashgar Prefecture Committee, met with the delegation or participated in related activities. They engaged in warm exchanges with entrepreneurs, promoted Xinjiang's open policies and investment environment, and expressed their willingness to provide a more market-oriented, law-based, and internationalized business environment for international investment and development in the region. Under the meticulous arrangements of relevant units in the autonomous region and prefectures and cities, the delegation visited and exchanged views at cross-border ports, free trade zones, high-tech parks, and specialty industries in Horgos, Kashgar, and Urumqi. They also attended an investment promotion symposium in Urumqi and had face-to-face exchanges with relevant departments and entrepreneurs in Xinjiang.

On September 12, over 200 people, including a delegation of foreign enterprises, a border tour delegation organized by the Shanghai Federation of Industry and Commerce, a Xinjiang business delegation organized by the Shanghai Non-Local Enterprises (Chambers of Commerce) Confederation, a delegation of young entrepreneurs from Shanghai, and a delegation of young entrepreneurs organized by the Shanghai Society for Promotion of the Guangcai Program, gathered in Kashgar for the "2025 Shanghai-Xinjiang Industrial Cooperation Conference". During the event, entrepreneurs actively exchanged views, sharing their achievements and intentions in investing in Xinjiang and Kashgar, and discussing the broad prospects for Shanghai-Xinjiang industrial cooperation.

Meng Qingyuan, Director of the Shanghai Liaison Office in Xinjiang and Chief Commander of Shanghai's Aid to Xinjiang, Qiang Pengcheng, Deputy Director of the Shanghai Municipal Government's Cooperation and Exchange Office, Su Lin, Vice Chairman of SPAFCC, and Fan Hong, Secretary-General of SHFIA, accompanied the participants during the tour. The investment inspection tour was co-organized by SPAFCC and SHFIA.

On September 29 when the 2025 presentation ceremony of the Shanghai Magnolia Gold Award was held, SHFIA hosted its 5th networking event for Shanghai Magnolia Award laureates from foreign enterprises. The event was attended by officials including He Dongbing, Deputy Director of the Shanghai Municipal Commerce Commission, Jing Ying, Chairman of the Shanghai NGO Network for International Exchanges, and Huang Feng, Chairman of SHFIA, as well as 11 award laureates from SHFIA's member enterprises.

黄峰会长在致辞中表示,今年,项目迎来关键里程碑,首批老窝镇中学学生初中毕业,有6名同学于9月入学禄劝职业高级中学,接受全日制中等职业教育,标志着项目实现从义务教育阶段向职业教育阶段的延伸。

在各方见证下,黄峰会长、晏发富校长共同签订合作备忘录,标志着"职业启航计划"正式启动。未来,双方将在学生培养、实习、就业等方面开展广泛合作。

In the morning of September 18, the launch ceremony for the "East-West Cooperation: Yunnan Youth Skills Training and Employment Project - Career Takeoff Plan" was held at Luquan Vocational High School in Kunming City, Yunnan Province. Bian Huixia, Director of the Kunming Liaison Office of the Shanghai Municipal People's Government Office, delivered a speech at the ceremony, which was attended by officials from the Yunnan Provincial Department of Commerce, the Yunnan Provincial Department of Education, the Luquan County People's Government, the Lushui Municipal Human Resources and Social Security Bureau, and the Yunnan Association of Enterprises with Foreign Investment (YAEFI). Representatives from SHFIA and YAEFI's member enterprises, including 3M China, Sony China, Ford, PVH, Amway Yunnan, Swire Coca-Cola Yunnan, Marubeni Kunming, Nippon Paint Yunnan, Firmenich Kunming, KFC Kunming, and Sunwah Tea, were also present.

In his speech, Huang Feng, Chairman of SHFIA, stated that this year, the Yunnan Youth Skills Training and Employment Project reached a key milestone: Laowo Town Middle School saw its first batch of graduates, and six of them were admitted to Luquan Vocational High School in September to receive full-time secondary vocational education, marking the project's extension from compulsory education to vocational education.

In the presence of all parties, Chairman Huang Feng and Principal Yan Fafu signed a memorandum of understanding, marking the official launch of the project's "Career Takeoff Plan". In the future, the two sides will collaborate extensively in student development, internships, and employment.

Zhao Qiang, Director of Government Affairs at 3M China., spoke on behalf of the foreign enterprises present at the ceremony.

That afternoon, representatives from SHFIA and foreign enterprises also visited Luquan Vocational High School's training base — they held discussions with school leaders and six Laowo Town Middle School graduates, while enterprise representatives presented books to the students. SHFIA and Shanghai Stock Exchange's International Exchange and Cooperation Center co-held training on "Interpretation of Measures for the Administration of Strategic Investments by Foreign Investors in Listed Companies"

On September 10, SHFIA and the Shanghai Stock Exchange's International Exchange and Cooperation Center co-held a foreign strategic investment training session at the China Securities Museum. Yu Bingguang, Senior Partner at AllBright Law Offices, interpreted the Measures for the Administration of Strategic Investments by Foreign Investors in Listed Companies, which took effect on December 2, 2024. Participants engaged in in-depth discussions on regulatory policies, practical issues, and corporate development paths for foreign strategic investments. Representatives from the Shanghai Securities Regulatory Bureau, the Shanghai Stock Exchange, and 32 foreign enterprises attended the event. Prior to the training, the participants also visited the China Capital Market Reform and Opening-up Exhibition.

SHFIA and Changning District Commerce Commission co-hosted symposium on tax credit policy for profit reinvestment by foreign enterprises

On September 11, the Changning District Commerce Commission and SHFIA co-hosted a symposium on the tax credit policy for profit reinvestment by foreign enterprises at the Hongqiao Business Service Center. Seven member enterprises, including Bosch, Yokogawa Electric, OCS, PPG, Oji Paper, Brother, and Asics, attended the symposium, which was moderated by Wilson Ma, Deputy Secretary-General of SHFIA.

Wang Yejun, Deputy Secretary-General of SHFIA, focused on the policy background, historical evolution, and key points of the policy announcement; officials from the Shanghai Municipal Commerce Commission provided a detailed explanation of the highlights of reinvestment information reporting; and experts from finance and tax firms provided an in-depth analysis of the policy's core provisions, drawing on typical cases. Participating corporate representatives engaged in discussions on practical issues such as policy applicability and operational procedures.

中国人民银行上海总部宏观审慎管理部跨境人民币业务管理处周萍副处长围绕离岸贸易金融试点政策,分别就银行的选择和开户、试点业务范围、FT 账户开立和使用等内容进行讲解,并对一线和二线资金划转、跨二线划转资金类型、专营公司设立等企业需重点关注的问题进行解答。临港新片区管委会金融贸易处围绕《临港新片区支持离岸贸易高质量发展的若干措施》,聚焦政策落地关键环节进行详细解读。作为本次试点金融机构之一,工商银行上海市分行国际业务部谢纾副总经理围绕银行支持离岸贸易的相关举措,介绍了政策试点后的实际操作及离岸贸易金融工具支持。

SHFIA held seminar on pilot policies for offshore trade financial services

On September 19, SHFIA, in collaboration with the Singapore Enterprise Centre (Shanghai Representative Office of Singapore Chamber of Commerce in China), held a seminar on pilot policies for offshore trade financial services themed "New Offshore Opportunities That Accelerated Trade Growth". Representatives from the Shanghai Headquarters of the People's Bank of China, the Administration Committee of the Lingang New Area of the China (Shanghai) Pilot Free Trade Zone, and the Shanghai Branch of the Industrial and Commercial Bank of China provided interpretations of the pilot program for the comprehensive reform of offshore trade financial services from various perspectives. Representatives from nearly 30 member enterprises, including Umicore, Wilmar International, Oji Paper, and Marubeni, attended the event.

Zhou Ping, Deputy Director of the Cross-Border RMB Business Management Division of the Macroprudential Management Department at the Shanghai Headquarters of the People's Bank of China, addressed the pilot policies for offshore trade finance, covering bank selection and account opening, pilot business scope, and the opening and use of FTZ accounts. She also addressed key issues for enterprises, such as tier-1 and tier-2 fund transfers, types of cross-tier-2 fund transfers, and establishment of specialized trading enterprises. The Finance and

Trade Department of the Administration Committee of the Lingang New Area presented a detailed interpretation of the *Several Measures to Support the High-Quality Development of Offshore Trade in the Lingang New Area*, focusing on key aspects of policy implementation. And Xie Shu, Deputy GM of the International Business Department of the Shanghai Branch of the Industrial and Commercial Bank of China, one of the pilot financial institutions, discussed the bank's measures to support offshore trade, including practical implementation and financial instruments supporting offshore trade following the pilot program.

The United Nations Conference on Trade and Development (UNCTAD) released the Chinese version of the *World Investment Report 2025* at the 25th China International Fair for Investment & Trade (CIFIT). On September 24, SHFIA and Shanghai Hongqiao International Central Business District co-held a seminar, which was attended by more than 30 people, including officials from the Social Work Department of the CPC Shanghai Municipal Committee, commerce commissions of Minhang, Changning, Qingpu, and Jiading districts, the Shanghai Municipal Investment Promotion Center, as well as representatives from research institutes, universities, and foreign enterprises. The seminar was moderated by Ding Suiliang, Deputy Secretary-General of SHFIA.

Li Nan, Director of the Investment and Enterprise Division of UNCTAD, explained the new landscape and hot topics of global investment and shared policy recommendations and action plans for digital economy investment. Wilson Ma, Deputy Secretary-General of SHFIA, focused on the theme "Observations on Foreign Investment in China and Transformation of Investment Promotion Methods" to provide an in-depth analysis of foreign investment patterns and trends, and analyze new directions for attracting foreign investment. During the interactive session, speakers and attendees engaged in in-depth discussions on topics such as Shanghai's foreign investment landscape and policies, and opportunities and challenges facing investment in China under the new circumstances, particularly in emerging sectors such as AI and the digital economy.

Jia Ruimeng, China GM of Bosch Connected Industry, delivered an opening speech and introduced key figures for Bosch's 2024 fiscal year, Industry 4.0 dual strategy, and sustainable development. Bosch experts also presented Bosch's innovative R&D in the driving and riding sectors, focusing on user experience, and innovative two-wheeled rides. At the ceremony, Wu Zhiyong, Lucas Lima, Ding Suiliang, Ma Xinrong, Pan Tianyi (Marketing Director of Sun Paper), and Liu Chunyuan (ESG Manager of M&G Stationery) jointly assembled a puzzle piece themed "Co-Building a Green Value Chain, Writing a Sustainable Future."

Previously, Shuzan Euno, in collaboration with Sun Paper and M&G Stationery, launched the Rare Animal-Themed Carbon-Neutral Notebooks, the first product in the Chinese pulp and paper industry to receive an ISO 14068-1 carbon neutrality declaration and verification, providing a practical example for collaborative carbon reduction across the value chain. Su Yujie, Head of Sustainability, Communications, and Brand for Asia at Shuzan Euno, Pan Tianyi, Marketing Director of Sun Paper, and Liu Chunyuan, ESG Manager of M&G Stationery, discussed the collaborative carbon-neutral notebook project during a roundtable discussion. And Prof. Dong Nannan from the School of Architecture and Urban

Planning at Tongji University, presented on the theme "Three Conceptual Meanings of Nature and Innovation of Biodiversity Planning and Design."

Participants also visited Shanghai's first low-carbon museum, the Shanghai Carbon Secret Museum, where they gained a firsthand understanding of the climate change crisis, learned about the carbon footprint of products, and experienced low-carbon living scenarios and zero-carbon products.

MNC Regional Headquarters ESG Branch: Localizing ESG Practices in MNCs – How DEI Can Be Rooted in Chinese Social Issues

On September 16, SHFIA's MNC Regional Headquarters ESG Branch hosted a seminar themed "Localizing ESG Practices in MNCs — How DEI Can Be Rooted in Chinese Social Issues". Huang Feng, Chairman of SHFIA, attended the event, along with Lu Weiqiang, Vice Chairman of the MNC Regional Headquarters ESG Branch and Head of Sustainability at Sika Sarnafil Waterproofing Systems (Shanghai) Co., Ltd., who also delivered a speech. The seminar, moderated by Ding Suiliang, Deputy Secretary-General of SHFIA, brought together representatives from renowned enterprises and organizations such as Evonik, Sanofi, ManpowerGroup, SGS, and Women Alliance Group (WAG), as well as ESG experts, to discuss the unique application and innovative pathways of international DEI concepts in China.

In his speech, Vice Chairman Lu Weiqiang emphasized that DEI practices represent a systematic project that should be integrated with local social needs. DEI is not just an empty concept, but practices rooted in the local community. He expressed hope that the discussion would pool the wisdom of all parties and jointly promote the deepening and implementation of ESG practices in China. The event featured a keynote address by Zheng Shengyin, a distinguished ESG expert at the AIFC Global Development Institute and the first Chinese ESG expert on the Global Impact Investing Network (GIIN) panel. She systematically outlined China's ESG development path and core social issues, navigating macro trends and micro practices.

During the MNC practice sharing session, Li Fangfei, Secretary-General of the MNC Regional Headquarters ESG Branch and Head of Corporate Communications and Public & Government Affairs for Evonik Industries Greater China, introduced Evonik's "Growth Without Limits" program, which specifically empowers female chemical engineering students at Chinese vocational colleges to fulfill Evonik's mission and create social value. Huang Lin, Head of Corporate Culture, Inclusion, and Employee Experience for Greater China at Sanofi (China) Investment Co., Ltd., shared the evolution of the DEI strategy from 1.0 to 2.0. 上海市节能减排中心总经理齐康作开场致辞,他强调,政府与企业携手合作是推动绿色低碳发展的关键。LEED 北亚区市场转化与拓展高级经理蔡圣君重点解读了今年发布的 LEED v5 新标准;奥雅纳董事、中国区可持续发展业务负责人王凌飞以《气候变化下的韧性治理:从发展思路到行动解决方案》为题,分享了韧性治理的系统化思路和落地实践;渣打银行结合案例,分享了金融工具如何支持企业在气候适应和绿色转型中的融资需求。

圆桌讨论环节由 LEED 北亚区教育及专业支持总监李雪玲主持。瑞安房地产、奥雅纳、渣打银行和科思创的嘉宾代表围绕"跨行业韧性实践:从愿景到执行的关键议题",分别就社区韧性改造、跨学科解决方案、金融赋能可持续发展和新材料助力安全与节能等话题展开交流。

Urban Renewal Branch: Climate Resilience and Corporate Sustainability Forum- **Key Guidance for Addressing Climate Change**

On September 17, the "Climate Resilience and Corporate Sustainability Forum: Key Guidance for Addressing Climate Change," hosted by SHFIA's Urban Renewal Branch, was held at the association. The forum focused on the challenges posed by climate change and the paths for corporate green transformation, bringing together experts and scholars from the government and industries such as construction and finance. It was also attended by representatives from nearly 40 of the branch's member enterprises. The forum was moderated by Zhang Ye, Secretary-General of SHFIA's Urban Renewal Branch and GM of Public Relations at Shui On Land.

Qi Kang, GM of the Shanghai Energy Conservation and Emission Reduction Center, delivered the opening remarks, emphasizing that collaboration between government and business is key to promoting green and low-carbon development. Cai Shengjun, Senior Manager of Market Transformation and Development for LEED North Asia, focused on the new LEED v5 standard released this year. Wang Lingfei, Board Director and Head of Sustainability for China at Arup, presented on the theme "Resilience Governance under Climate Change: From Development Concepts to Action Solutions," sharing systematic thinking and practical implementation of resilience governance. And a representative from Standard Chartered Bank, drawing on case studies, shared how financial instruments can support the financing needs of businesses in climate adaptation and green transformation.

The roundtable discussion was moderated by Li Xueling, Director of Education and Professional Support for LEED North Asia. Focusing on the theme "Cross-Industry Resilience Practices: Key Issues from Vision to Implementation", representatives from Shui On Land, Arup, Standard Chartered Bank, and Covestro discussed topics such as community resilience

transformation, interdisciplinary solutions, financial empowerment for sustainable development, and new materials for safety and energy conservation.

Smart Manufacturing Branch: Exchange Meeting on Collaborative Innovation for "Smart Low-Altitude Air Transport" Supply Chain

On September 18, SHFIA's Smart Manufacturing Branch, in collaboration with Wujing Town in Minhang District, held an exchange meeting on collaborative innovation for "smart low-altitude air transport (LAAT)" supply chain. The event brought together resources from businesses, governments, industrial parks, incubation platforms, and universities, focusing on the low-altitude economy and building a platform for connecting enterprises across the supply chain. Li Junxia, Deputy Governor of Wujing Town, Zhu Yue, Secretary-General, and Zheng Qian, Deputy Secretary-General of the Smart Manufacturing Branch, attended the event, where more than 30 people, including those from branch member enterprises and representatives from FIEs Community@Hongqiao, were also present.

Participations visited the LAAT Equipment Selection Center and gained a close-up look at the national low-altitude aircraft selection platform and the "Lingchou" LAAT digital system. Relevant technicians presented the current situation and challenges of the domestic low-altitude economy, the advantages of LAAT systems, and the development strategy for the low-altitude industry. They also released eight low-altitude technical needs, including electric propulsion, power system, airframe structure, and flight control. During the discussion session, participating enterprises actively raised questions, and representatives from incubators, members of the Minhang Low-Altitude Economy Industry Alliance, and the School of Aeronautics and Astronautics of Shanghai Jiao Tong University responded and answered questions from their respective perspectives. Wujing Town Deputy Mayor Li Junxia stated that Wujing is the core driving force of Minhang's low-altitude economy and expressed hope

that the event will promote collaboration among industry, academia, research, application, and finance, building an innovative ecosystem for the low-altitude industry. It's worth noting that the meeting was the first industry chain supply and demand matching event organized by SHFIA's Smart Manufacturing Branch.
