2025 上海外资医药健康企业创新论坛举行

10月14日,在上海虹桥国际中央商务区管理委员会、上海市闵行区人民政府的指导下,由上海市外商投资协会、上海市生物医药科技产业促进中心、闵行区商务委、闵行区科委共同主办,由上海市医学会提供学术支持的 2025 上海国际生物医药产业周主题论坛"上海外资医药企业创新论坛"成功举办,论坛聚焦外资医药企业"开放合作、激发创新:共筑外资医药健康行业高质量发展"这一主题。闵行区区委副书记、区长吴强、副区长谭瑞琮、虹桥国际中央商务区管理委员会副主任杨旭波、中国医院协会副会长毛群安、市医学会会长邬惊雷、市卫生和健康发展研究中心主任金春林,及多位政府部门领导,和来自学界及相关机构、跨国医药企业的嘉宾出席。

2025 Shanghai Foreign-Invested Pharmaceutical and Healthcare Enterprises Innovation Forum was held

On October 14, the 2025 Shanghai Foreign-Invested Pharmaceutical and Healthcare Enterprises Innovation Forum was held. Under the guidance of the Administration Committee of the Shanghai Hongqiao International Central Business District and the Minhang District People's Government, the forum, as part of the International Biopharma Industry Week Shanghai 2025, was co-organized by SHFIA, the Shanghai Biopharma Technology Industry Promotion Center, the Minhang District Commerce Commission, and the Minhang District Science and Technology Commission, with academic support from the Shanghai Medical Association (SMA). It focused on the theme "Open Cooperation and Innovation: Co-Promoting High-Quality Development of the Foreign-Invested Pharmaceutical and Healthcare Industry." Attendees included Wu Qiang, Deputy Secretary of the CPC Minhang District Committee and Governor of Minhang District; Tan Ruizong, Deputy Governor of Minhang District; Yang Xubo, Deputy Director of the Administration Committee of the Shanghai Hongqiao International Central Business District; Mao Qun'an, Vice Chairman of the Chinese Hospital Association (CHA); Wu Jinglei, Chairman of SMA; Jin Chunlin, Director of the Shanghai Municipal Health Development Research Center (SMHDRC); officials from various government departments; and representatives from the academic community, related institutions, multinational pharmaceutical enterprises.

Huang Feng, Chairman of SHFIA, and Wu Jinglei, Chairman of SMA, delivered welcome speeches. Tan Ruizong, Deputy Governor of Minhang District, addressed the audience and introduced Minhang District's measures and achievements in the planning, policy support, and platform development of the biopharma industry. Mao Qun'an, Vice Chairman of CHA, shared the highlights of the *Blue Book on the Development of Digital Healthcare in China*. Yao Hong, Director of the Benefits and Guarantee Division of SMHSA, presented on the *Several Measures on Promoting High-Quality Development of Commercial Health Insurance to Support Innovation in the Biopharmaceutical Industry*. Xu Wenkai from the Biopharmaceutical Division of SMSTC, interpreted new policies for Shanghai's biopharmaceutical industry. And Han Liyan, Deputy Director of MDSTC, introduced Minhang District's policies for the biopharmaceutical industry.

Both roundtable discussions were moderated by Jin Chunlin, Director of SMHDRC, and guests focused on multi-tiered healthcare security and the application of medical big data, exploring new paths for the development of Shanghai's medical and health sector. The first roundtable discussion focused on the theme "How to Develop a Multi-Tiered Healthcare Security System to Meet People's Diverse Health Needs", with guests coming from Fudan University, Pacific Health Insurance, Organon China, and Boehringer Ingelheim. The second roundtable discussion focused on the theme "Sharing and Building a New Paradigm of Digital Cooperation in the Medical and Health Sector, Promoting the Implementation of Global R&D in China and Creating a Globally-Competitive Shanghai Practice", with guests coming from SMA, the

Shanghai Health Data Industry Association, Fudan University, Roche Diagnostics, and Bristol-Myers Squibb.

黄峰会长在东京出席日本经济广报中心演讲会

10月15日,应日本经济广报中心邀请,上海市人民对外友好协会理事、市外资协会会长黄峰在东京出席日本经济广报中心主办的演讲会,发表题为《中国外商投资政策更新及中美经贸关系对在华日企的影响》的演讲,就中国最新外商投资政策、中美经贸关系演变趋势对在华日企的机遇与挑战进行了解读,重点介绍了境外投资者以分配利润直接投资税收抵免政策、政府采购中实施本国产品标准政策、外国投资者对上市公司战略投资管理办法等内容,并回答了参会企业的提问。约40家日本企业参加了演讲会。会前,黄峰会长与日本经济广报中心专务理事竹原玲儿进行了会谈。



Chairman Huang Feng spoke at seminar organized by Japan Institute for Social and Economic Affairs in Tokyo

On October 15, at the invitation of the Japan Institute for Social and Economic Affairs (Keizai Koho Center), Huang Feng, Board Director of the Shanghai People's Association for Friendship with Foreign Countries and Chairman of SHFIA, attended a seminar hosted by the institute in Tokyo. He delivered a speech titled "Updates to China's Foreign Investment Policies and Impact of Sino-US Economic and Trade Relations on Japanese Enterprises in China," interpreting the opportunities and challenges for Japanese enterprises in China based on the latest Chinese foreign investment policies and the evolving trends in Sino-US economic and trade relations. He highlighted the tax credit policy for direct investment by foreign investors using distributed profits, the implementation of domestic product standards in government procurement, and the management measures for strategic investments in listed companies by foreign investors. He also answered questions from participating enterprises. About 40 Japanese enterprises attended the seminar. Prior to the event, Chairman Huang Feng held talks with Reiji Takehara, Executive Director of the Nikkei Public Relations Center.

为持续推进长三角一体化发展、深化长三角区域外资企业交流合作,放大进博会投

资溢出效应, 10 月 30 日,在第八届进博会正式开幕前 6 天,由上海市商务委员会、虹桥国际中央商务区管委会指导,上海市外商投资协会、虹桥外企联谊会主办,上海市外国投资促进中心支持的"对接进博会长三角外资企业交流会"在虹桥国际中央商务区成功举行。市商务委副主任何冬宾、虹桥国际中央商务区管委会党组书记、常务副主任孔福安、副主任杨旭波、中国国际进口博览局副局长李国清、上海市外资协会会长黄峰出席,来自长宁、闵行、青浦、嘉定和虹桥商务区管委会的商务部门负责人,以及上海和江苏的部分外资协会、重点企业代表 50 余人参会。

何冬宾主任表示,在助力跨国公司在中国市场布局过程中,长三角区域应立足自身特色,充分发挥各自优势,上海坚持"开放、共享、协调"的发展理念,协同长三角外资企业共同发展。希望广大外资企业充分利用虹桥国际中央商务区、中国国际进口博览会等开放平台优势,与中国企业深化合作,实现互利共赢。

孔福安书记介绍了商务区发展情况,他表示,虹桥有着服务国内国际双循环的重要功能和引领长三角高质量发展的核心定位,面对全球贸易格局的深刻变化,虹桥正构建联通国际国内市场的"彩虹桥"。

中国国际进口博览局副局长李国清介绍第八届进博会整体情况。

市外资协会副秘书长马蓝向与会嘉宾分享了虹桥外企联谊会的基本情况、服务范围及主要服务内容。

企业交流发言环节,永恒力、毕马威作为联谊会成员单位企业发言。随后,来自长三角地区的多家外资企业及协会代表——瑞迪博士、塞拉尼斯、尤希路、京信电子、阿尔派、阿法拉伐以及吴江区外商投资企业协会相关负责人分享了在长三角地区的发展情况。

FIEs Community@Hongqiao held "Exchange Meeting for Foreign Enterprises across Yangtze River Delta to Connect with CIIE"

To further promote the integrated development of the Yangtze River Delta, deepen exchanges and cooperation among foreign enterprises across the region, and amplify the spillover effects of the China International Import Expo (CIIE), the "Exchange Meeting for Foreign Enterprises across Yangtze River Delta to Connect with CIIE" was held on October 30, six days before the expo's official opening. Under the guidance of the Shanghai Municipal Commerce Commission (SMCC) and the Administration Committee of the Shanghai Hongqiao International Central Business District, the meeting was co-organized by SHFIA and FIEs Community@Hongqiao, with support from the Shanghai Foreign Investment Promotion Center. He Dongbin, Deputy Director of SMCC; Party Secretary and Executive Deputy Director Kong Fu'an and Deputy Director Yang Xubo of the Administration Committee of the Shanghai Hongqiao International Central Business District; Li Guoqing, Deputy Director of the China International Import Expo Bureau; and Huang Feng, Chairman of SHFIA, attended the meeting, along with more than 50 participants, including heads of commerce departments from Changning, Minhang, Qingpu, Jiading districts and the Hongqiao International Central

Business District, and representatives from foreign investment associations and key enterprises in Shanghai and Jiangsu.

He Dongbin stated that in assisting multinational corporations with their market expansion in China, the Yangtze River Delta region should leverage its unique characteristics and strengths. Shanghai adheres to the development philosophy of "openness, sharing, and coordination," working collaboratively with foreign enterprises across the Yangtze River Delta region. He expressed the hope that foreign enterprises fully utilize the advantages of open platforms such as the Hongqiao International Central Business District and the China International Import Expo to deepen cooperation with Chinese enterprises and achieve mutual benefit and win-win results.

Secretary Kong Fu'an introduced the development of the Hongqiao International Central Business District, stating that Hongqiao plays a crucial role in serving the domestic and international dual circulation and holds a core position in leading the high-quality development of the Yangtze River Delta. Facing profound changes in the global trade landscape, Hongqiao is building a "rainbow bridge" connecting international and domestic markets.

Li Guoqing, Deputy Director of the China International Import Expo Bureau, introduced the overall situation of the 8th CIIE.

Wilson Ma, Deputy Secretary-General of SHFIA, shared the basic information, service scope, and main services of FIEs Community@Hongqiao.

During the enterprise exchange session, Jungheinrich and KPMG, as member enterprises of FIEs Community@Hongqiao, delivered speeches. And representatives from several foreign enterprises and foreign investment associations in the Yangtze River Delta region, including Dr. Reddy's, Celanese, Yushiro, Kyungshin Electronics, Alpine, Alfa Laval, and the Wujiang District Association of Enterprises with Foreign Investment Enterprises, shared their developments in the Yangtze River Delta region.

23 日下午,由重庆市商务委主办的"投资重庆·渝见商机"2025 年长三角外资协会联盟重庆行对接会召开。会上,重庆市商务委副主任叶力娜向与会嘉宾全面介绍重庆的发展优势与投资潜力,同时,还对长三角外资协会联盟发出合作倡议,希望其发挥桥梁纽带作用,常态化举办交流活动,共同推动双方合作落地见效。

长三角外资协会联盟代表、上海市外商投资协会会长黄峰在讲话中表示,此次活动是积极响应今年7月国家出台的鼓励外商投资企业境内再投资政策,为东部外商投资企业提供与中西部地区加强交流、拓展市场、投资对接的良好机遇。

Chairman Huang Feng participated in "Yangtze River Delta Alliance of Foreign Investment Associations' 2025 Trip to Chongqing"

From October 23 to 24, the "Yangtze River Delta Alliance of Foreign Investment Associations' 2025 Trip to Chongqing" was successfully held. More than 50 representatives from foreign investment associations and enterprises in Shanghai, Jiangsu, Zhejiang, Anhui, Xiamen, Weihai, Yunnan, and other regions gathered in Chongqing to connect with various districts and counties and open platforms in Chongqing. Huang Feng, Chairman of SHFIA, and representatives from member enterprises Magna, Rockwell, Bosch, Alten, and Nachi-Fujikoshi participated in the trip.

In the afternoon of October 23, a matchmaking meeting for trip participants, was held by the Chongqing Municipal Commerce Commission (CMCC). At the meeting, Ye Lina, Deputy Director of CMCC, comprehensively introduced Chongqing's development advantages and investment potential to the participants. She also issued a cooperation initiative to the Yangtze River Delta Alliance of Foreign Investment Associations, hoping that it would play a bridging role, hold regular exchange activities, and jointly promote the implementation and effectiveness of cooperation between the two sides.

On behalf of the alliance, Huang Feng, Chairman of SHFIA, stated in his speech that the event was a positive response to the national policy issued in July 2025 to encourage foreign enterprises to reinvest in China, providing a good opportunity for foreign enterprises in eastern China to strengthen exchanges, expand markets, and connect with investments in the country's central and western regions.

On October 24, the delegation visited Yuzhong District, the Bishan High-tech Industrial Development Zone and the Dazu Shuangqiao Economic Development Zone for inspection and exchange. They visited and surveyed key local enterprises such as Changan Auto Global R&D Center, Seres Automotive Phoenix Smart Factory, Fudi Lithium Battery, and Longrun Steering Gears.

To deepen foreign pharmaceutical and healthcare enterprises' understanding of Shanghai's blueprint of high-end medical industry and build a bridge for collaborative communication among the government, industrial parks, and enterprises, SHFIA, together with the Minhang District Commerce Commission and the Administration Committee of the New Hongqiao International Medical Center, jointly held a special visit to the New Hongqiao International Medical Center on October 14 as part of the "2025 Shanghai Foreign-Invested Pharmaceutical and Healthcare Enterprises Innovation Forum". SHFIA held seminar on IPR to celebrate CIIE

To help foreign enterprises better address intellectual property rights (IPR) protection issues at exhibitions, SHFIA held a seminar on IPR to celebrate the CIIE in the afternoon of October 23. Nearly 30 legal, intellectual property, and related business specialists from foreign enterprises participated.

Zhao Ping, Director of the Rights Protection and Assistance Department of the Shanghai

Intellectual Property Protection Center, shared insights on the theme "Working Mechanism for Intellectual Property Protection at Exhibitions". Huang Juexin, Partner of Shanghai Watson & Brand Law Firm, presented on the theme "Common Situations and Countermeasures for Intellectual Property Disputes at Exhibitions". During the Q&A session, participants raised questions on issues such as trademark infringement determination standards, evidence collection for reverse counterfeiting, the impact of false promises on infringing parties, and the selection of strategies for protecting the rights of well-known product packaging and decoration, which the two experts answered one by one.

协会联合长宁商务委举办《关于深化跨境投融资外汇管理改革有关事宜的 通知》政策解读会

为精准对接国家外汇管理改革新政策,帮助区域内外资企业把握跨境投融资便利化新机遇,10月24日下午,长宁区商务委联合上海市外商投资协会在大虹桥营商服务中心举办《关于深化跨境投融资外汇管理改革有关事宜的通知》(汇发〔2025〕43号)政策解读会。吸引了众多协会会员和长宁区外资企业代表积极参与。

会上,国家外汇管理局上海市分局的专家对汇发〔2025〕43 号文进行全面解读,系统介绍了深化跨境投资与融资外汇管理改革、优化资本项目收入支付便利化等关键内容,着重分析了新政在简化业务流程、扩大政策惠及面、提升资金使用效率等方面带来的实质性利好。建设银行的专家从金融机构的视角分享了对接新政的具体服务举措。重点企业围绕自身业务实际,就跨境资金运营等具体问题展开提问并得到解答。

SHFIA and Changning District Commerce Commission co-held policy interpretation seminar on *Announcement on Matters Concerning Deepening the Reform of Forex Management for Cross-border Investment and Financing*

To accurately align with China's new forex management reform policies and help foreign enterprises seize new opportunities arising from the facilitation of cross-border investment and financing, SHIFA joined hands with the Changning District Commerce Commission to hold a policy interpretation seminar on the *Announcement on Matters Concerning Deepening the Reform of Forex Management for Cross-border Investment and Financing* in the afternoon of October 24 at the Hongqiao Business Service Center. The seminar attracted representatives from SHFIA member enterprises as well as those in Changning District.

At the seminar, experts from the Shanghai Branch of the State Administration of Foreign Exchange provided a comprehensive interpretation of Document No. 43, systematically introducing key aspects such as deepening the reform of forex management for cross-border investment and financing and optimizing the facilitation of capital account income payments. They focused on analyzing the substantial benefits brought by the new policy in simplifying business processes, expanding policy coverage, and improving the efficiency of capital utilization. Experts from China Construction Bank shared specific service measures for aligning with the new policy from the perspective of financial institutions. And key enterprises raised

questions and received answers regarding specific issues such as cross-border fund operations based on their own business realities.

分会活动 | 城市更新分会 X 绿色低碳发展分会:零碳园区沙龙——探讨外资企业参与零碳园区建设的合作路径

2025 年 7 月,国家发改委、工信部、国家能源局联合印发《关于开展零碳园区建设的通知》,为工业园区的零碳转型提供明确的政策指引。以此为契机,10 月 20 日,由国家级经济技术开发区绿色发展联盟(绿盟)、上海市外商投资协会联合主办的"零碳园区沙龙——探讨外资企业参与零碳园区建设的合作路径"在协会举行。活动汇聚了南京江宁、常熟、南通经开区及宝山工业园区的代表,及近 30 家会员企业代表。活动由绿盟业务经理严思静主持。

协会黄峰会长在开场致辞中表示,本次活动旨在构建一座桥梁,将园区的需求与外企的技术紧密链接,创造合作机会,共同为中国"3060"双碳目标贡献力量。绿盟邵先辉总监详细解读了国家级经开区的绿色发展现状与零碳园区建设的核心需求。协会 6 家拥有成熟实践经验的会员企业代表从不同维度分享了多元化的零碳转型路径。施耐德电气聚焦实施路径规划,埃顿集团与罗克韦尔分别从"工业新基建"与"绿色智慧框架"角度解读了园区升级方案;远景智能、SGS与妙盈科技则构成了"实践-标准-管理"的完整链条,依次剖析了全周期案例、认证体系与各阶段实施策略。与会代表们围绕具体的改造需求与技术方案,进行了多轮次交流。

Urban Renewal Branch X Green and Low-Carbon Development Branch: Salon on Zero-Carbon Industrial Parks — Exploring Cooperation Paths for Foreign Enterprises to Participate in Zero-Carbon Industrial Park Development

In July 2025, the National Development and Reform Commission, the Ministry of Industry and Information Technology, and the National Energy Administration jointly issued the Announcement on the Development of Zero-Carbon Industrial Parks, providing clear policy guidance for the zero-carbon transformation of industrial parks. Taking this opportunity, on October 20, the "Salon on Zero-Carbon Industrial Parks – Exploring Cooperation Paths for Foreign Enterprises to Participate in Zero-Carbon Industrial Park Development," co-organized by the Green Development Alliance for National Economic and Technological Development Zones ("Green Alliance") and SHFIA, was held at the association. The event brought together representatives from Nanjing's Jiangning District, Changshu, the Nantong Economic & Technological Development Area, and the Baoshan Industrial Park as well as nearly 30 member enterprises. It was moderated by Yan Sijing, Business Manager of Green Alliance. In his opening remarks, Chairman Huang Feng noted that the salon aimed to bridge the needs of industrial parks with the technologies of foreign enterprises to create cooperation opportunities and co-contribute to China's "30/60" Dual-Carbon Goals. Shao Xianhui, Director of the Green Alliance, provided a detailed interpretation of the current green development in national-level economic and technological development zones and the core needs for zerocarbon park development. Representatives from six SHFIA member enterprises with mature

practical experience shared diversified zero-carbon transformation paths from different perspectives – Schneider Electric focused on implementation path planning, while Eton Group and Rockwell interpreted park upgrade solutions from the perspectives of "new industrial infrastructure" and "green smart framework," respectively; and Envision Intelligence, SGS, and Miotech covered a complete value chain of "practice-standard-management," analyzing full-cycle case studies, certification systems, and implementation strategies at each stage. The participants engaged in multiple rounds of exchanges regarding specific transformation needs and technical solutions.

分会活动 | 绿色低碳发展分会: 《上海无废城市建设、绿色低碳转型方案 及节能审查和碳排放评价新规解读》

为帮助外资企业进一步理解《上海市无废城市建设条例》《上海市加快推进绿色低碳转型行动方案(2024-2027年)》及《固定资产投资项目节能审查和碳排放评价办法》等相关政策,2025年10月24日下午,由协会绿色低碳发展分会(以下简称"分会")主办、巴斯夫(中国)有限公司支持的外商投资企业双碳能力建设系列大讲堂(第八期)在协会举行。来自外商投资企业的30余位代表参加,分会秘书长、巴斯夫中国政府事务资深总监蒋永勇主持活动。

蒋永勇秘书长指出,近期密集出台的各项政策既是挑战,更是外资企业通过绿色创新提升竞争力的战略机遇。上海市节能减排中心副总经理齐康围绕国家与上海市关于加快经济社会发展全面绿色转型的系列政策文件作系统梳理介绍与解读,为企业规范开展项目节能降碳管理、应对新规要求提供指引。参会代表们还围绕循环回收体系构建、降低包装回收成本、相关鼓励政策申报等问题与专家展开详实交流。

Green and Low-Carbon Development Branch: Interpretation of Shanghai's Zero-Waste City Development, Green and Low-Carbon Transformation Plan, and New Regulations on Energy Conservation Review and Carbon Emission Assessment

To help foreign enterprises further understand relevant policies such as the "Shanghai Regulation on the Development of Zero-Waste City", the "Shanghai Action Plan for Accelerating Green and Low-Carbon Transformation (2024-2027)", and the "Measures for Energy Conservation and Carbon Emission Assessment of Fixed Asset Investment Projects," the eighth event of the Foreign Enterprise Dual-Carbon Capacity-Building Seminar Series was held at the association in the afternoon of October 24. It was hosted by SHFIA's Green and Low-Carbon Development Branch, with support from BASF (China) Co., Ltd. More than 30 representatives from foreign enterprises attended the seminar, which was moderated by Jiang Yongyong, Secretary-General of SHFIA's Green and Low-Carbon Development Branch and Senior Director of Government Affairs at BASF China.

Jiang Yongyong pointed out that the recent flurry of policies present both challenges and strategic opportunities for foreign enterprises to enhance their competitiveness through green innovation. Qi Kang, Deputy GM of the Shanghai Energy Conservation and Emission Reduction Center, systematically reviewed and interpreted a series of national and municipal

policies on accelerating the all-round green transformation of economic and social development, providing guidance for enterprises to standardize project-related energy conservation and carbon reduction management and comply with new regulatory requirements. Participants also engaged in detailed exchanges with experts on issues such as developing a recycling system, reducing packaging recycling costs, and applying for relevant incentive policies.

陆创 AI 加速器主理人沈文轩介绍了张江 AI 创新小镇,展示了 AI 助力企业发展的多种可能性。张江科学城·数智天地智慧源项目负责人章斯豪向来访嘉宾介绍了张江科学城·数智天地的基本情况。上海工业数字化研究院院长、工业数字化规划咨询专家陈廷炯对《上海市加快推动"AI+制造"发展的实施方案》政策文件的发布背景作介绍,并解读了"AI+制造"三年实施方案蓝图。罗克韦尔自动化(中国)有限公司智能制造创新研究院院长李栋、埃孚汽车系统(上海)有限公司精益推进经理高波、麦格纳亚洲区卓越运营总监马晓兰和麦格纳电子高级新产品工艺导入经理朱健三家行业龙头企业分别向与会代表们分享了各自企业核心制造场景中 AI 深度应用的"标杆样本",为智能制造企业提供从技术选型到效益转化全运营链条中的可复用"场景化 AI 落地指南"。

Smart Manufacturing Branch: Sharing Session on "AI + Manufacturing" Policies and Leading Enterprises' Scenario-Based AI Applications

In the afternoon of October 28, SHFIA's Smart Manufacturing Branch held a sharing session on "AI + manufacturing" policies and leading enterprises' scenario-based AI applications at L HUB in Qiantan World Trade Center Phase I. The session focused on the policy dividends and core technologies of "AI + Manufacturing" as it transitions from "concept exploration" to "scenario implementation," attracting nearly 40 member enterprises including Budweiser, Aptiv, Mettler, Nachi-Fujikoshi, and Emerson Process.

Shen Wenxuan, Head of the Lujiazui Innovation AI Accelerator, introduced the Zhangjiang AI Innovation Town, showcasing the various possibilities of AI assisting enterprise development. Zhang Sihao, Head of the Zhangjiang Science City · Digital Intelligence World Smart Source Project, introduced the basic situation of his project to the participants. Chen Tingjiong, Dean of the Shanghai Industrial Digitalization Research Institute and an expert in industrial digitalization planning and consulting, introduced the context of the *Implementation Plan for*

Accelerating the Development of "AI + Manufacturing" in Shanghai and interpreted the three-year implementation plan blueprint for "AI + Manufacturing". Experts from three leading enterprise in the industry – Li Dong, Dean of the Smart Manufacturing Innovation Research Institute of Rockwell Automation (China) Co., Ltd., Gao Bo, Lean Promotion Manager of ZF Automotive Systems (Shanghai) Co., Ltd., Ma Xiaolan, Director of Operations Excellence for Magna Asia, and Zhu Jian, Senior New Product Process Introduction Manager of Magna Electronics – shared "benchmark examples" of deep-level AI application in their core manufacturing scenarios with the participants, providing smart manufacturing enterprises with a reusable "scenario-based AI implementation guide" across the entire operational chain from technology selection to result conversion.

市生态环境局执法总队章营军书记作在开班动员中表示,生态环境执法要兼顾监管与服务,期望通过此次培训,为企业送政策、解难题。市生态环境局执法总队法制科黄渊智科长围绕"紧跟环保执法新动态,合法守规高质量发展"解析了国家生态环境保护新趋势及上海执法特色。市生态环境局执法总队五大队树伟副大队长以"共建绿色防线:自动监控设施运行管理要求及守法要点"为题,阐述了污染源自动监控系统的重要性及运维管理规范。奉贤区生态环境局执法大队花正东副大队长就"环保现场检查合规迎检"进行分享。市环境保护产业协会魏化军副秘书长作总结发言,他期望企业将所学应用于实践,共推绿色低碳发展。

Green and Low-Carbon Development Branch: Training exclusively for foreign enterprises by Law Enforcement General Brigade of Shanghai Municipal Breau of Ecology and Environment

In the afternoon of October 29, the Law Enforcement General Brigade of the Shanghai Municipal Breau of Ecology and Environment (SMBEE) joined hands with the Shanghai Association of Environmental Protection Industry (SAEPI) and SHFIA's Green and Low-Carbon Development Branch to hold a training session exclusively for foreign enterprises on Shanghai's ecology and environment-related law enforcement. The event aimed to enhance the awareness of foreign enterprises on ecological and environmental laws and regulations, strengthen their environmental management capabilities, and jointly promote green, low-carbon, and high-quality development. The training session was attended by nearly 70 representatives from foreign enterprises, and moderated by Ding Suiliang, Deputy Secretary-General of SHFIA.

In his opening remarks, Zhang Yingjun, Party Secretary of the SMBEE Law Enforcement General Brigade, said that ecology and environment-related law enforcement should balance supervision and service, and he hoped that the training would deliver policies and solve problems for enterprises. Huang Yuanzhi, Chief of the Legal Affairs Section of the SMBEE Law Enforcement General Brigade, analyzed the new trends in national ecological and environmental protection and the characteristics of Shanghai's law enforcement, focusing on "keeping up with the new dynamics of environmental law enforcement and achieving highquality development through legal compliance." Shu Wei, Deputy Captain of the Fifth Law Enforcement Brigade of SMBEE, delivered a speech titled "Building a Green Defense Line: Requirements for the Operation and Management of Automatic Monitoring Facilities and Key Points of Compliance," elaborating on the importance of automatic pollution source monitoring systems and their operation and maintenance management standards. Hua Zhengdong, Deputy Captain of the Law Enforcement Brigade of the Fengxian District Bureau of Ecology and Environment, shared insights on "Compliance in Environmental On-site Inspections." And Wei Huajun, Deputy Secretary-General of SAEPI, gave a concluding speech, expressing his hope that enterprises would apply their learnings to practice and jointly promote green and low-carbon development.
